Team fees are \$ 35 a week. Usually if you have 5 players playing that comes to \$7 a player. If you only play 4 matches the fee is still \$ 35.00 . This means the player that did not play pays \$ 7 or you can split it among the other players to make the weekly fee 8.75. The amount that goes to the APA and the travel fund remains constant and when there is only 28 in the envelope it does not cover expenses.
